General

Student finance to be paid out to the bank account of an authorized person

Do you receive student finance and do you wish this to be paid out to the bank account of somebody else (not an official authority), for example a person you authorized?

This is possible. Just pass on this person's account number in Mijn DUO.

Do you receive student finance and do you wish this to be paid out to the bank account of an official authority? Then draw up a statement in which you declare that you want your student finance to be paid out to this authority. Be sure to mention the authority's name and account number in your statement. The statement must be signed by you and by the authority.

Send in your statement together with this form.

Bij 4.1 By direct debit

Payment by direct debit means that you authorize DUO and your bank to debit the instalment from your bank account each month (ongoing SEPA authorization). DUO's Direct Debit ID is NL22ZZZZ509732090000. In the event of a disagreement over a direct debit payment, you can have the payment reversed within 56 days.

Bij 5 Correspondence

If you currently receive correspondence from DUO digitally and you would like us to send future notification emails to the authorized person, log into 'Mijn DUO' and register the email address of the authorized person under 'Mijn gegevens'. You can also make any future changes to the e-mail address in Mijn DUO. If you would like to authorize someone to look after your affairs digitally in Mijn DUO, you can arrange this at digid.nl/machtigen. If you currently receive correspondence from DUO digitally and you would like us to send this by post to an authorized person in future, log into 'Mijn DUO' and under 'Mijn gegevens' indicate that you would like to receive correspondence by post. If the postal address changes in the future, you will also need to change this in Mijn DUO.

DUO and your data

Your details will be retained in DUO's systems. DUO will handle and protect your personal data with the utmost care and in accordance with the relevant legal obligations and the requirements set out in relevant privacy legislation. If you would like more information about how DUO handles your personal data, please visit duo.nl. DUO will of course verify your data with other agencies to ensure that you receive what you are entitled to. DUO informs the Public Prosecutor whenever abuse is uncovered.
